

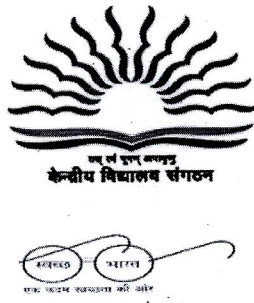

महोदया/महोदय,

उपरोक्त विषय के संदर्भ में दिनांक 19.04.2024 को केन्द्रीय विद्यालय संगठन (मु.), नई दिल्ली से जारी पत्र की निरंतरता में के वि सं (मु.) से जारी पत्र संख्या F.110331/EDPOLA/1/2024-25/Academic दिनांक 31.07.2024 को आवश्यक कार्यवाही हेतु अग्रेषित किया जाता है।

कोलकाता संभाग के सभी केन्द्रीय विद्यालय के प्राचार्यों को निर्देश दिया जाता है कि पत्र का अक्षरत: अनुपालन सुनिश्चित करें। पत्र के अनुसार इस वर्ष (2024-25) के लिए Serviving Employee of Cat I to Cat II (Civil & Defense)/ Cat I to Cat III (Project/IHL) के लिए कक्षा I/ Balvatika में छात्र संख्या 40 व कक्षा 2 से आगे कि कक्षाओं हेतु छात्र संख्या 45 रखी गई है।

Balvatika हेतु पूर्व में जारी प्रतीक्षा सूची से, कक्षा- I हेतु OLA Portal से जारी Cat I to Cat II (Civil & Defense)/ Cat I to Cat III (Project/IHL) प्रतीक्षा सूची से प्रवेश दिया जा सकता है तथा कक्षा II से आगे की कक्षाओं हेतु (जहाँ भी औसत छात्र संख्या 45 से कम है) के वि सं प्रवेश मार्गदर्शिका 2024-25 का पालन करते हुए Cat I to Cat II (Civil & Defense)/ Cat I to Cat III (Project/IHL) हेतु दिया जा सकता है।

Subject: Admission of KV TC Cases for class II to VIII and Fresh Admissions in KVs -reg.

Madam/Sir,

In continuation to this office letter even number dated 19.04.2024, it is to inform that the competent authority has approved the following:

1. Admission of KV TC cases for classes II to VIII as supernumerary to the section strength of 50 with the approval of concerned DC, KVS RO for the Academic Session 2024-25, provided the option of redistribution/re-allotment of nearby KVs is exhausted, as was done in case of class IX to XII.
2. One time approval for fresh admissions for the Academic Session 2024-25 beyond permissible section strength to the serving employees of Project/IHL including CISF and other Central Government employees posted at the Project/ IHL (only).
3. One-time approval for fresh admissions for the Academic Session 2024-25 beyond permissible section strength for wards of MEA personnel.
4. It is further reiterated that fresh admissions for the Academic Session 2024-25 to the serving employees of Project/IHL, wards of Central Government employees, Central Government PSUs /ABs, defence forces, uniformed Personnel i.e. Category I, II in Civil/Defence sector KV and Category I,II and III in Project/ IHL KVs, up to the class strength of 40 in Class 1 and 45 for other classes may be permitted. This provision is extended only to the waitlisted candidates for class I as per the waitlists drawn by online admission (OLA) portal for class I, newly joined/ mid-term transfer cases; and for other classes as per the KVS Admission Guidelines 2024-25.
5. Admission in Balvatika will be done on the similar line as of class I, as mentioned above.
6. Last date for all fresh admission is extended to 31.08.2024 for the Academic Session 2024-25.

Further, while reallotting/redistributing the KV, the Deputy Commissioner of the concerned Region will ensure that the allotted KV, as far as possible, should be within 8 KM from the residence of the child to avoid any negative impact on her/his health due to such commutation. Sibling cases of KV TC should be allotted in the same KV.

Furthermore, all the KVs be asked to convey the parents waiting for admissions on the basis of KV TC in the current session that any future KV TC based admission shall be governed by the provisions contained in the extant Admission Guidelines.

These amendments be disseminated to all the stakeholders immediately.

This issues with the approval of competent authority.
